AKTA KASTAM 1967

PERINTAH KASTAM (LARANGAN MENGENAI EKSPORT) (PINDAAN) 2019

PADA menjalankan kuasa yang diberikan oleh subseksyen 31(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Eksport) (Pindaan) 2019**.

(2) Perintah ini mula berkuat kuasa pada 15 Mac 2019.

Pindaan Jadual Kedua

2. Perintah Kastam (Larangan Mengenai Eksport) 2017 [*P.U. (A) 102/2017*] dipinda dalam Jadual Kedua, berhubung dengan butiran 6—

(a) dalam ruang (2), dengan memotong subbutiran (24) dan (25) dan butir-butir yang berhubung dengannya dalam ruang (3); dan

(b) dalam ruang (5), dalam perenggan (iii), dengan menggantikan perkataan “Forest Department Sarawak” dengan perkataan “Sarawak Timber Industry Development Corporation (STIDC)”.

CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF EXPORTS) (AMENDMENT) ORDER 2019

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Prohibition of Exports) (Amendment) Order 2019**.

(2) This Order comes into operation on 15 March 2019.

Amendment of Second Schedule

2. The Customs (Prohibition of Exports) Order 2017 [*P.U. (A) 102/2017*] is amended in the Second Schedule, in relation to item 6—

(a) in column (2), by deleting subitems (24) and (25) and the particulars relating to them in column (3); and

(b) in column (5), in paragraph (iii), by substituting for the words “Forest Department Sarawak” the words “Sarawak Timber Industry Development Corporation (STIDC)”.
